

Together Credit Union – Form for Requests to Opt-In to Sharing Personal Information under CCPA/CPRA

INSTRUCTIONS: This form is used for submitting a “Request to Opt-In” to sharing of Personal Information under the California Consumer Privacy Act of 2018 (“CCPA”) as amended by the California Privacy Rights Act of 2020 (“CPRA”). This form, Together Credit Union’s California Privacy Policy, and all other California specific privacy forms, can be found at any California branch location as well as on the Together Credit Union homepage at togethercu.org, under the link at the bottom of the page titled “Privacy Choices for CA Residents.” Specifically, this form allows you to exercise your right to opt-in to the sharing of your personal information for cross-context behavioral advertising.

By submitting a request through this form, you are directing Together Credit Union that it may start sharing any Personal Information it may have about you to third parties for the purpose of cross-context behavioral advertising. Together Credit Union does not sell Personal Information. All information collected will be used to facilitate the request and will be retained in accordance with the CCPA/CPRA. You may opt-out of sharing for cross-context behavioral advertising at any time by completing a Do Not Share My Personal Information form which can be found here “Do Not Share My Personal Information” and also on the Together Credit Union homepage at togethercu.org, under the link at the bottom of the page titled “Privacy Choices for CA Residents” or at any California branch location.

I understand that Together Credit Union will attempt, but does not guarantee, to comply with this request, or respond to me with an explanation for why Together Credit Union cannot comply with this request, within 15 business days from the date Together Credit Union receives this request. I understand that Together Credit Union does not sell my personal information.

Such form will request a statement under perjury of law that you are in fact the parent/legal guardian of the minor child. Additionally, please include a certified copy of a birth certificate or legal document to provide proof of the status of parent/legal guardian. All information collected will be used to facilitate the request and will be retained in accordance with the CCPA/CPRA.
